AGREEMENT

Chang Hon Kwan Taekwon-Do, LLC conducting a Taekwon-Do Class at the Peak at West Meadows Recreation Center, located at 6612 S. Ward Street, Littleton, Colorado 80127, has agreed and does agree to provide competent, professional instruction in all phases of the Korean Martial Art (Karate), known as Taekwon-Do. Each student of, or member of, the Chang Hon Kwan Taekwon-Do Class agrees to pay all regular normal charges or dues for the instruction provided.

It is recognized and understood by Chang Hon Kwan Taekwon-Do, LLC and by the students or members of the class that Taekwon-Do is a physical contact sport or martial art and that there is the ever present possibility of personal injury even when instruction is under the supervision of qualified instructor personnel. Chang Hon Kwan Taekwon-Do, LLC agrees to provide qualified instructor personnel during all classes, practice sessions, and contests. Each student or member agrees to comply with the general and specific instructions given by the instructor personnel. These agreements by Chang Hon Kwan Taekwon-Do, LLC and by the students or members shall also be binding during any testings, competitions, special camps or special sessions which are conducted under the auspices of the Chang Hon Kwan Taekwon-Do Class.

In consideration of the mutual agreements spelled out above, I covenant and agree for myself, my heirs, administrator or executor, and assigns that I will not bring any suit or proceeding at law or in equity against Chang Hon Kwan Taekwon-Do, LLC or its officers, its employees, or its agents or prosecute any claim, demand, action, or cause of action for or on account of any damage, loss, or injury either to myself, or to any other person or property, or both, resulting from my receiving instruction or training of any type in Taekwon-Do or from my participating in the activities of the Chang Hon Kwan Taekwon-Do Class either at its usual locations or at any other location such as testings, contests, satellite classes, special classes, or summer camps. This covenant is agreed to openly and without reservation.

It is expressly understood that this is a covenant not to sue as to the above mentioned parties and is not a general or specific release.

I further agree that I have carefully read the foregoing covenant not to sue and know the contents thereof, and sign the same as my own free act. If I am under the age of 18 years, I also understand that my parent or guardian must approve this agreement as well as myself.
